You may receive the over 65 or disability homestead exemption in addition to the general homestead, but you may not receive both the over 65 and disability homesteads.

Below is an example for calculating your taxes:

If the appraised value of your home is \$100,000 and you are receiving the general homestead exemption from a school district that grants both the state-mandated and optional homestead exemptions you would calculate your taxes as follows:

Appraised Value:	\$100,000
Less 20% optional exemption: \$100,000 X 20%	- 20,000
Less state-mandated general homestead:	<u>- 25,000</u>
Taxable Value	\$ 55,000
X Tax Rate per \$100/value (\$1.30)	<u>X 1.30%</u>
<b>TAXES DUE:</b>	<b>\$715</b>
